What are the requirements for candidates?

- Be a member of a Zonta club
- Have held an elected office in the club for at least 2 years or have served as chair on one of the district committees.
- The District Governors, Lt. Governors & Area Directors should have been at least president of a club for at least 1 year

(Zonta Int. Bylaws Article XIV Districts, Section 6 Officers)

- Governor: Preside over D14 in all matters, inform, connect with ZI Board & Headquarters, attend Area Meetings, hold District Conference, appoint and assist D14 Committees, co-sponsor and support goals, programs, projects, of Zonta International, attend ZI Convention,
- Lt Governor: Supports and represents the Governor and is always also chair of the membership committee

Tasks

- Area Director: plans and conducts at least 1 Area meeting per year; visits clubs at least one time during the biennium; attends D14 Board meetings; acts as an intermediary between clubs and the Board; promotes the goals and programs of Zonta International.
- Vice Area Director: supports and represents the Area Director and prepares for the role as an Area Director

Tasks

- Treasurer: is responsible for financial management, prepares budget for next biennium; reports regularly to the D14 Board and to the District Conference; hands over to the successor in a timely manner (no later than 45 days after the end of the biennium); the Treasurer's books must be available for inspection by the Board and all designees
- Secretary & Parliamentarian: are appointed by the Governor

Tasks

- Nominating Committee: the committee, consisting of 3 elected members, calls on all clubs to nominate candidates for the positions to be filled
- Collects nominations and verifies requirements of nominees
- draws up the list of candidates (if possible 2 or more each and at least 5 for the NC)
- sends a report to clubs and the Board 60 days prior to the D-Conference
- reports to the D-Conference where nominations from the floor can be submitted immediately afterwards

Important: no member of the NC shall be eligible for nomination for any office; however, one may, if she holds an elected office in the District, hold an appointed office at any time. This also applies to offices on international committees

Expenditure refund

- Travel expenses, accommodation, etc. will be covered by the District.
- Reimbursement follows the "D14 Reimbursement Guidelines", version of 09 June 2018.
